Phlebotomy Training Program

The Certificate of Completion in the Phlebotomy Technician I program will be awarded to successful graduates of this program. The program is designed for individuals planning to achieve the status of Certified Phlebotomy Technician I along their career paths. After successful program completion, and passing a national phlebotomy certification examination, individuals shall have achieved eligibility to apply for certification as a Phlebotomy Technician I from the State of California.

CPT I Externship: 40 hours

Student will be attending an externship to draw a minimum of 50 venipunctures, 10 skin punctures, and observe 2 arterial punctures, with hours to be arranged outside of class.



Phlebotomy Training Program

Our program is 60 hours of classroom instruction and hands on learning; the externship is a minimum of 40 hours. The program will run two or three cycles of classes per year. The next course for Phlebotomy Training will be offered on Fridays, from 8:00 a.m.-4:00 p.m., plus the externship.

The Requirements

- o Must be 18 years of age or older
- o Must possess a High School Diploma or a GED Certificate
Foreign Transcripts – Special rules apply
- o Must possess a Social Security Number
- o Must attend a MANDATORY Information Meeting
- o Reading Requirement:
Student must have an AA degree or higher from a U.S. College OR you must take the MJC Reading Accuplacer test and obtain a score of 70 or higher OR successfully completed Reading 82 or higher, with a “C” or higher.

The Application Process

- o Fill out the application completely.
- o Include proof of age – Copy of Driver’s License OR State ID Card (Picture ID)
- o Copy of High School Diploma or GED Certificate or Transcripts
- o Copy of Social Security Card
- o Reading Requirement – Copy of transcripts or assessment test results meeting above requirements.
- o Receipt from Information Meeting

The Selection Process

Assessment Testing

It is highly recommended that you complete the assessment testing promptly – because of the great demand for this program, selection will be by computer lottery of all qualified applications received in our office by the deadline, Wednesday, January 6, 2010, 12:00 p.m.

NOTE ⇨ **In order to take the assessment test:**

1. You **MUST** have a student identification number (“w” number) through Modesto Junior College. If you do not already have a student ID number with Modesto Junior College, you must apply online at mjc.edu or at the MJC Admissions Office. It can take up to 48 hours to receive your number. Be sure to allow enough time **BEFORE** you take the test - you cannot test without this number.
2. Picture identification is required for **ALL** testing. **No identification? No testing.**
3. Check-in will be required before you start the test. You must tell them you are there to take the Accuplacer Reading Assessment for the Phlebotomy Program.

Accuplacer Reading Assessment

The reading test is the Reading Comprehension component of the Accuplacer English/Reading assessment. It is untimed. Students in the Allied Health field, automotive, and other disciplines may be required to take this test. Candidates applying to the Phlebotomy Program are required to reach a minimum score of 70. Students may retest after a minimum of 60 days has passed.

Tests are given on a first come, first serve basis.
