## IV. PUBLIC COMMENTS

Steve Collins mentioned can't remember if he was the $4^{\text {th }}$ or $5^{\text {th }}$ president of what was then called the Academic Senate where they were just trying to figure out what the Academic Senate was supposed to do. That was before the $10+1$ and all the legislative support came in. It does his heart good to see the way the senate has institutionalized the decision making.

Something that S . Collins has been able to do as President is sit in on closed sessions. This Board is working very hard to get along with one another even though there are disagreements amongst them. They are civil to each other, discuss things very well and he is pleased to see more Board members are going to have office hours.
S. Collins mentioned that we are going ahead with some hiring. He and the Vice-President's are in agreement so far with the district to go down to the first three of the hiring positions on the IOR Position Rankings. It is unknown how much further down they will go if any. There are two positions on the list, The Welding Technology and the Counselor - Athletics and Transfer Emphasis that can be funded using categorical money and have no impact on the general fund. Both are important positions. The Welding classes can be filled and meets a real need in the community and will help in the economy and help the college in student success metrics due to allowing us to increase the number of completers. The same can be said of the Counselor position for Athletics and Transfer. The Athletics Program is a rich source of students who are completing and transferring and becomes richer the more the Athletics Department is supported to encourage the students to complete and transfer and that counselor position would enable us to do that.

At some point those two position will be rolled into the general fund but is unknown when that point will be. J. Abbott stated that the Welding position would be funded at least through December 2029/2021 and would have an option of extending that funding for another three years if necessary.
S. Collins mentioned that he has his first meeting with the new president on March 1 and has a long list of items to discuss.
J. Abbott made a brief comment about the Accreditation visiting team of two members who will be on campus on March 28, 2019. They have asked the research office to randomly select 15 online courses from fall 2018 and will be given access to those courses for review. Of those courses, the faculty will be notified to be on stand-by in case they need to be interviewed by the team.
V. ## a. Associated Students Senate Report - Carlee Walsh

Approximately 425 meals are served per week for FLOW. Questions were asked about enrolled students who don't have the ID sticker on the ID Card in regards to food and are being left out. The food pantry on Thursdays was mentioned as not needing to have the ID sticker to obtain food. It was requested of ASMJC to consider ways to provide meals to this group. It was mentioned that the church across the street provides free breakfasts.

c. President's Report - Curtis Martin

Leading from the Middle is an organization that is faculty leadership, mid-level administrators and staff that carry the culture of an institution over the years. It is one of the few professional development opportunities that allow that sort of middle level leadership to obtain the training needed to ensure that we work as smoothly as possible.

The project for the Leading from the Middle conference which took place Feb. 6 - 9, 2019 was on Onboarding. There was fascinating discussion because it was evident that each time a conversation began there was a number of other things that should be done at the institution that require as much prioritization as Onboarding.

Both C. Martin and H. Hauselmann shared experiences from Leading from the Middle (LFM). LFM clarified the need to rethink how to onboard students when Guided Pathways rolls out. C. Martin shared experiences of the Guided Pathways Institute \#5.
C. Martin mentioned he contacted the President Houpis and forwarded our collective welcome from Academic Senate. He read the response from President Houpis. Some of the items President Houpis wishes to discuss with C. Martin and the Senate is the status of Guided Pathways and the assistance needed from him, the establishment of a center for Professional Development, expansion of online courses and degrees and ZTC/OER (Zero Textbook Cost/Open Educational Resources). There were other areas, but those were the first that came to his mind.

President Houpis will be coming to the next Academic Senate meeting on March 7, 2019.
