- 1. Transfer Model Curriculum (Associate Degrees for Transfer)** **B. Adams**  
B. Adams will be working with the Agriculture faculty to develop ADTs for the new Agriculture Chancellor's Office Templates (COTs). She will work with the Economics instructor in spring to give him time to transition into his new role as a full-time faculty member.
- 2. C-ID** **R. Cranley**  
MJC has been granted C-IDs for 140 courses. Following the meeting, two more courses will be submitted.
- 3. CurricUNET Implementation/Issues** **B. Adams/L. Miller**  
Various tickets are pending. Critical staffing changes at Governet, CurricUNET's parent company may be having an effect on the rate of turn-around time for repair tickets. S. Kincade may follow up with Governet directly.
- 4. Outcomes Assessment Workgroup (OAW)** **K. Ennis/E. Kerr**  
The OAW, while moving rather seamlessly with CLOs and PLOs, is struggling with higher order outcomes with General Education Learning Outcomes (GELOs) and Institutional Learning Outcomes (ILOs) as required for Program Review. What is the role of assessment data in terms of the big picture? What do we do with it? How do we plan? The group will meet again on 12/5. It was asked if there are minutes of the dialog, as this will provide good evidence of this process and inquiry to the accreditors. H. Townsend confirmed that OAW minutes make this clear.
- 5. AB 86 and SB1070 Legislation** **P. Mendez**  
Representatives are still being sought for Math and English for the AB86 consortium. P. Mendez advised the committee to become familiar with SB173, which will have a significant impact on community colleges. AB86 was the planning element, while SB173 will be about implementation and moving forward. The CCC will be the center of resources in the region for adult education. Thursday, November 20, at 2:30 MJC liaisons will meet with regional partners in adult education inclusive of Stanislaus County, the Mother Lode, and the Central Valley. A writing team is being formed to look at the first of the final draft due in in December. All are invited who are interested in Adult Education. P. Mendez noted that there are common themes that run through Student Equity, SSSP, and adult education. It was noted that it has been difficult getting faculty to participate. Some reasoned it was due to the meeting times, which often are concurrently scheduled with peak instructional times. P. Mendez advised the group that the impact of AB86, SB1070, and SB173 on credit and noncredit instruction would be profound.

## **X. UNFINISHED BUSINESS**

- 1. Curriculum Review Process** **B. Adams**  
The Course Proposal Justification form, a product of the refined "Curriculum Review Process", is a living document. For this reason it will appear on the agenda for further discussion, review, and improvement as it is taken into usage by faculty. M. Adams had raised questions about the definitions for unit modalities provided on page 4 of the current form. He reported that math faculty had attempted to use the form and had concerns, specifically, that the definitions given do not seem to allow for online labs. Official sources that provide definitions of "lab" modalities do not seem to exist, however, ratios for contact/homework hours for various modalities are established in Title 5. There was lengthy reflection and discussion that eventually focused on what it takes to garner curricular approval for online instruction of a course. M. Adams and the committee concluded that the DE Addenda provided a framework and process for establishing online laboratory instruction.

The committee also ensures that curriculum is sound, comprehensive and responsive to the evolving needs of our students as well as the academic, business, and local communities.

This effort will be launched by a series of Regional College Conversations with community college practitioners.
