Discipline Update:

The Intersegmental Curriculum Faculty Workgroup (ICFW) recently met and finalized the following Transfer Model Curriculum (TMCs):

- o Environmental Science
- o Hospitality Management

- o Social Work and Human Services - (Area of Emphasis TMC)

The TMCs are now posted to c-id.net. Please note that while they are available for review and consideration, this should not be viewed as the initiation of the AD-T development process, until such time as California Community College Chancellor's Office (CCCCO) template is made available.

C-ID Course Validation

In order to allow new course submissions to C-ID, and to support the transition to ASSIST Next Gen, C-ID has temporarily turned off course validation between ASSIST and c-id.net. During this time C-ID will validate courses through the Chancellor's Office Curriculum Inventory (COCI). We ask that Articulation Officers ensure their college's course listings are up to date in COCI. Please contact support@c-id.net if you have any questions.

C-ID 2.0 Website Update

C-ID has been working closely with the CCC Technology Center to prepare C-ID 2.0 for user testing near the end of May, with a public release expected June 30, 2017. CCCCO Policy Change: C-ID Course Approval and ADTs

The CCC Chancellor's Office, in collaboration with the ASCCC, has developed a new policy for C-ID course approval and ADT submissions, which aligns with ASCCC [resolution](#) 15.02.

Please note that this policy pertains to ADTs aligned with TMCs that do not have an appropriate number of Course Outline of Record Evaluators (COREs) to complete the review process. Currently this applies to: Agriculture, Information Technology and Information Systems, Film/TV/ Electronic Media, and Studio Arts.

The new policy is as follows:

ADTs in which courses pending C-ID approval over 45 days may be included in the degree program if the application demonstrates evidence that those courses have been submitted to and are under review in the C-ID system (e.g., submitted, resubmitted, in progress, conditional and/or approved). Thus, for evidence, please submit a screenshot from the C-ID website that includes the date of submission, course name, and college. This new ADT policy will take effect on March 1, 2017. ADT proposals in the queue before March 1 that do not have final C-ID approval will be returned and colleges must resubmit with either C-ID course approval or provide evidence that demonstrates that responses to C-ID submissions are taking more than 45 days. This does not negate the requirement of C-ID approval and colleges should continue to pursue their efforts to obtain C-ID approval. Please contact support@c-id.net if you have any questions.
