C-ID General Updates

C-ID Curriculum Development Team - New Member!

We are pleased to welcome Professor Dominic Calabrese (Sierra College) as the new C-ID Process and Review Director. In this capacity, Dominic will help conduct research on C-ID data in order to assess the effectiveness of the system. Please help us welcome him to the C-ID community!

AB 705 (Irwin, 2017) Implementation & C-ID

At this time, there are no proposed revisions to C-ID descriptor prerequisites due to AB 705 implementation. Please note that modifying prerequisites on a course outline of record will require colleges to resubmit courses for review and there is no guarantee the courses will be approved.

C-ID now has resources regarding AB 705 on the resources tab of c-id.net, including four (4) pre-transfer level templates developed by the Math and Quantitative Reasoning Taskforce (MQRTF). Association of Independent California Colleges and Universities (AICCU) & C-ID

Discipline Updates

Office Technology and Business Information Worker

We are pleased to announce that twenty-two (22) new descriptors for Office Technology & Business Information Worker (BIW) are finalized and available on the C-ID website here: <https://www.c-id.net/descriptors/final>.

In addition, the Faculty Discipline Review Group (FDRG) finalized three (3) model curricula (MC) for the discipline. It should be noted that MC falls outside of SB1440/440 and is not subject to the limits and mandates associated with such legislation. As a result, MCs do not obligate colleges to develop MC-aligned degrees or certificates. Each college may determine if the model curriculum is appropriate for their program and students. Hospitality Management

The Hospitality Management FDRG is currently proposing revisions to three (3) Hospitality Management descriptors:

Elementary Teacher Education

Due to the California Commission on Teacher Credential (CTC) revisions to the Elementary Teacher Education Multiple Subject program standards, C-ID will conduct an out-of-cycle review for the TMC for Elementary Teacher Education to ensure that it aligns with the standards requirements. 5-Year Review Updates

The purpose of reviewing C-ID descriptors on a 5-year cycle is two-fold: one to ensure that descriptors are current and reflect changes in the field that would impact curriculum, and two, to provide an opportunity to
