AGREEMENT AND RELEASE OF LIABILITY

This agreement is between: (Parent if a minor) _____ and Yosemite Community College District and its instructors, members, agents, authorized guests and affiliated organizations.

I am aware that Community Education activity classes may involve strenuous physical activity and that myself or my child will be practicing and/or performing in situations that may be demanding and/or stressful.

I am voluntarily enrolling myself or my child in classes with knowledge of the risk involved, and I agree to accept any and all risk of injury that may occur in the normal course of events.

If I, or my child, has a disability or illness, I promise to consult with my attending health care provider before taking the above instruction.

I agree that I, my heirs, legal representatives and assigns do hereby agree to:

1. NOT make claims against Yosemite Community College District and or the Instructor (individually or collectively) for any damage to myself or my child or another resulting from my participation in this or any other program offered by Yosemite Community College District, and,

2. Waive, release, and discharge Yosemite Community College District and or Community Education Instructor from all claims or demands arising from injury or damage to myself or my child or another caused by myself or my child's participation in this program offered by Yosemite Community College District, Modesto Junior College Community Education.

I promise to defend, indemnify, and hold harmless Yosemite Community College District, Modesto Junior College Community Education, and Community Education Instructors from any claims and actions by third parties alleging injury from my (or my child's) participation in the programs.

I have carefully read this agreement and fully understand its contents. I am aware that this is a release of liability and a contract between myself and Yosemite Community College District, Modesto Junior College Community Education, and sign it of my own free will.

MEDICAL CONSENT

In the event of any medical emergency while involved in program activities with Community Education, Modesto Junior College, or any of its representatives, is given the full authority to take action to protect the health and safety of the MJC Community Education student named above. Such treatment may include, but not be limited to, placing the student under the care of a doctor or in a hospital for medical examination and/or treatment, or in returning the student to their home (if such a return is deemed necessary after consultation with medical authorities). Any expenses required for the student's health and safety are to be paid by the student's parent/legal guardian.

As provided for in California Education Code Section 35330, I agree to waive all claims against the Yosemite Community College District and hold the District, its officers, agents and employees, harmless from any and all liability or claims, which may arise out of or in connection with my child's participation in this activity. This waiver shall not apply to any occurrences that may arise solely out of the negligence of the District, its employees or agents.

STUDENT CONDUCT FORM - Swimming

In an effort to guarantee an enjoyable and safe experience, conducive to learning and fun, participants in our classes, including sports and swimming, are asked to follow the code of conduct listed below. Proper student conduct is expected each time a student is on campus, from arrival until departure. It is important that the parent/guardian and student review and understand this code to ensure the safety and satisfaction of all participants. If this is a sports class/activity or swimming class, you will be asked to review and sign the Code of Conduct form at the same time the required Release of Liability form is signed and collected.

Modesto Junior College Community Education works hard to provide a successful, fun and informative class or program for your child. In exchange, we expect that all students, *regardless of age or ability*, to:

- In order for the swim coach/instructor to safely teach and control their classes, the children will need to be able to pay attention, follow instructions and stay with their class. It is not only disruptive, but also dangerous, to the rest of the students, if the instructor needs to ignore the class in order to get your child back with the group. If your child has a disability and may require additional assistance, please call our office at 575-6063 to discuss options.
- No running on the pool deck
- No splashing other children

In the event that there is a behavior/discipline problem, the following process will be applied:

- The instructor will issue a verbal warning and will inform the parent/guardian of the problem, either in person or by phone
- If the problem occurs again, the student will be dismissed from the program
- *No refund will be processed in the event of dismissal*
