A review of your MJC grades at the end of the summer 2015 semester indicates that you are **not in Good Standing**.

Students are considered “not in Good Standing” when the cumulative Modesto Junior College (MJC) GPA is below 2.0 and/or when more than 50% of the overall units attempted have the following grades: W, I, NC, and NP.

Your current standing is: Academic Dismissal

A Standing of Academic/Progress Dismissal indicates that you have failed to meet minimum requirements at MJC for three consecutive semesters. **You will be dismissed from the college and blocked from registration for one calendar year beginning with spring 2016 classes.**

In addition, you have lost your priority registration (per Title 5 §58108). This means that in future semesters you will register last, regardless of your eligibility status in other priority categories such as Disability Services, EOP&S, and Veterans status. If you have extenuating circumstances you may appeal your loss of Priority Registration/Enrollment. Appeals must be submitted by the established deadline for each respective term. Important Notice: This standing does not affect enrollment in fall 2015 classes. We encourage you to utilize all resources available at MJC to help you achieve success in all your courses.

If you have special circumstances that you think should allow you to continue taking classes at MJC during your dismissal, you must:

1. **Attend a Dismissal Workshop** during the fall 2015 semester.
2. **Meet with a counselor by November 18, 2015.** No spring 2016 readmission requests will be considered after this date.
3. **If you are enrolled in fall classes, you MUST bring a completed grade check form** at the time that you meet with a counselor. Your form must include a grade for all courses in which you are currently enrolled for which you have not yet received a final grade. Page 2 - Definitions

Students are considered in “Good Standing” when the cumulative Modesto Junior College (MJC) GPA is 2.0 or better and when less than 50% of the overall units attempted have the following grades: W, I, NC, and NP.

When students are not in good standing, they are placed on Probation. Three consecutive semesters not in good standing will lead to Dismissal from MJC.

There are **two** types of Probation and Dismissal:

- “Academic” which is based on your cumulative (overall) MJC GPA.
- ”Progress” which is based on the overall percentage of Withdrawal, Incomplete, and No Credit/No Pass marks on your record.

“**Academic Probation**” occurs when the student has enrolled in a minimum of 12 units at MJC and his or her cumulative grade point average falls below 2.0. If a student's cumulative GPA remains below 2.0 for three consecutive semesters, the student’s standing will be “Academic Dismissal.” The student will be dismissed from MJC for one calendar year.

MA1 = Academic Probation, first semester

MA2 = Academic Probation, second semester

MAD = Academic Dismissal

“**Progress Probation**” occurs when the student has enrolled in a minimum of 12 units at MJC and the percentage of W, I, NC, and NP’s reaches or exceeds 50% of the total attempted units. If this percentage remains at 50% or above for three consecutive semesters, the student’s standing will be “Progress Dismissal.” The student will be dismissed from MJC for one calendar year.

MP1 = Progress Probation, first semester

MP2 = Progress Probation, second semester

MPD = Progress Dismissal

Please note: It is possible for a student’s standing to include both Academic and Progress Probation and/or Dismissal at the same time.
