Note to Student: Establishing residence requires BOTH physical presence in California AND objective evidence that there is the intent to make California your home for other than a temporary purpose. The one-year-and-one-day residence period does not begin until you are present in California AND have demonstrated clear intent to become a California resident. Student will be required to present 2 to 3 forms of documentation of California presence as well as proof of financial independence.

The burden of proof to clearly demonstrate both physical presence and the intent to establish residency in California and financial independence lies with the student. Please note that additional documentation may be requested to assist a student's reclassification.

A student must demonstrate and provide proof of residency by:

- Citizenship status (If not U.S citizen, INS documentation will be requested)
 - Physical presence in California/ Intent to reside permanently
 - Financial Independence

All proofs must include the following information: (Proof must be dated after your CA arrival but prior to the Residency determination date).

1. Student's full name
2. California address
3. Residence Determination date

At least 2 California proofs (ex. of acceptable proofs below):

- Medical bills, utility bills, cellphone bills, active bank account, valid California identification, motor vehicle registration, registered to vote in CA, ownership or leased property, etc.

At least 1 Financial Independence proof (ex. of acceptable proofs below):

- Pay stub, CA unemployment EDD, CA verification of public assistance or county services, financial aid award letter, Social Security award letter, CA state income tax for the previous two years, W-2's for the previous two years

Part A: Legal Status (Title 5 54002 & 54045(c))

Students must obtain citizenship status for at least one year and a day prior to the opening day of the term for which you are petitioning. Documentation is required to be submitted to clarify student's status. To establish California residency, you MUST be a U.S. citizen, permanent resident, an applicant for permanent resident status, employment authorized, or possess a visa that does not preclude you from establishing domicile in the U.S. **Select the status that applies to you:**

Part C: Financial Independence (Ed. Code 68044 & Title 5 54032)

The law requires that financial independence be "among the factors to be considered" in reclassification and specifies how financial independence should be balanced against other factors, such as the passage of time, parent's residence, and the student's intent to establish residence elsewhere. In determining whether the student has objectively manifested intent to establish California residence, financial independence shall weigh in favor of finding California residence and financial dependence shall weigh against finding California residence.
