**ASMJC Shared Governance Council/Committees:**

A. YCCD Board Meeting: Jennifer Novoa:

President Novoa reported that Trustee D Martini has resigned from her position, and that MJC's President Houpis will finish his presidential term January 31<sup>st</sup>, 2021. President Novoa was also thanked by Chancellor Yong for showing interest in being part of the hiring process for the next MJC president. During this meeting, the annual security report was given as there were 12 crimes in 2017, 13 crimes in 2018, 12 crimes in 2019, and the 2020 report will be interesting to see given the virtual semesters. There was also a vote on how the trustee position should be filled, and, given a special election would be costly, it was decided to be open for applications.

- E. College Council: Samantha Carvajal:

Vice President Carvajal reported they pushed the mission and vision statements to the next meeting because it was not ready to be discussed at the time. The cc decision making principles are 1. Do what is best for our students. 2. Address social justice and equity. 3. Find a way to “yes”. 4. Be a beacon of hope. These decision-making principles will be enforced in college council whenever discussing and voting on topics for the school and students. There was also an enrollment update that was discussed in which across the state and nation, student enrollment has decreased. The leadership team is currently brainstorming ideas to help motivate students to enroll. Productivity this spring for enrollments is 13.83 which is decent considering the low enrollment of FTES this semester. The district reached 84% of target for FTES for spring 2021 which is a good high number for the school. They are also working on running starfish reports to help cluster sections and courses for students to help identify students that are close to graduating to help that flow continue and help benefit the students by finding the exact classes needed to have them graduate as soon as possible. They are mainly working on strategic ways of what students need pertaining to classes during this time and how to have a higher enrollment for full time equivalent students.

- I. Resource Allocation Committee: Hannah Ransdell/ Samantha Carvajal:

Vice President Carvajal reported In RAC they discussed a lot of budgeting topics such as the RACs budgeting calendars and timelines that pertain mostly to the committee itself. They also touched on the decision-making principles from College Council and saw ways to best fit our own decision-making principles that correlate to college councils but also fit the RAC committee’s purpose. They are currently in the works of getting a document for that first draft. They also went over the governor's budget for 2021-2022. The budget amount is staying flat compared to the 2020-2021 budget but there are also a lot of proposals being put into place, one of them being the proposal for pandemic help with students. Due to the pandemic, they are offering relief for low-income individuals, economic recovery through grants to small business, tax credits, and providing support to

facilitate reopening schools for in person education. There is a highly possible consideration of an Early Action Package to be expected in early Spring to provide targeted investments to populations affected by the pandemic which includes a One-time investment of \$100 million in emergency student financial assistance grants and a One-time resource of \$20 million for retention and re-enrollment strategies. In December 2020, Congress passed the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) which is a \$900 billion economic relief package. This will be released in the spring for students. They also have a proposal to Expand Zero-Textbook Cost Pathways with \$15 million more dollars compared to the 5-million-dollar investment they have already proposed. With the 5-million-dollar investment for these zero textbook cost classes, an average total of 23,00 students will be saving \$42million by 2022. This is just \$5million compared to the proposal of \$15 million we are putting down which will go a long way and help our students tremendously. There is also a \$0.6 million for the CCCCCO to coordinate a systemwide antiracism effort and the implementation of the new ethnic studies course requirement in the CSU as it affects community college transfer students.

C. Presidential Report: Jennifer Novoa

President Novoa began her report by wishing the senate a happy first week of the spring semester stating she hopes everyone got into the classes that they wanted and are excited to have another semester under your belt. As the senate knows, the week of the 25th is MLK week, and she just wanted to remind ASMJC that if they are not in class and or working you should be in these events since there are events. Other than that, she knows some of the senate has been emailing her about shared governance and not being able to make your committee meetings. She is in the process of trying to get the new schedule for shared governance since things are different with the structure this semester. If ASMJC members can continue to attend the meetings they were attending last semester, they should email her. She concluded her report by mentioning that ASMJC nominations and elections will be coming up soon, and to keep an eye out for them.
