No Report, President Ramirez mention that she attended the meeting and shared the ZTC Resolution.

Senator Lopez reported that they went over the Accreditation Visit Team Recommendation-Fall 2017, on how they would be deeply discussed, directly address them, and how they are going to be improved. They also went over the Yosemite Community College District Recommendation, mentioning that the seconded district recommendation needs to be improved. Lastly they discussed Student Learning Outcomes, and gave ideas to give short surveys for the faculty on how they use learning outcomes and include guided pathways to help.
Senator Lopez mentioned that the meeting will probably extended for one more hour.

Senator Joy reported that they met on Tuesday 13th and discussed an option for teachers to make their classes Online only in case of an emergency.

Director Novoa reported that they had a presentation by Sarah Schrader about the Resource Allocation Model. They also went over the Pirate Housing Grant, and mentioned that it has served 20 students and they hope many more will be getting this grant. Lastly, Chad Redwing presented the Institute of Applied Creativity and Community Transformation (Acct) at Modesto Junior College, it was approved by other constituents groups and College Council approved the first reading.

 - i. Instruction Council: Raymond Gonzales
Senator Gonzales reported that they met on April 7th 2020, they had a discussion on how to react to Covid-19 and the action Modesto Junior College has been taking. Several changes were made on Tittle 5; Section 55024 (e) (1) has added Covid-19 and its effects to the reason for Excused Withdrawals (EW), Section 55204 (e) (3) added that colleges will not be penalized financially for awarding the EW's, Section 55022 (a) (2) was amended so that students have the choice to have a course with a letter grade or a pass/no pass basis, Section 55022 (c) states that a pass/no pass will not affect financial aid, academic probation and course attempts. They also discussed the Emergency Temporary Blanket for Distance Education Addendum for Summer 2020 and Fall 2020. The Summer plan would be due by May 20th, and Fall by July 1st 2020. These plans will include schedules of class meetings, how many courses can be accommodated, local approval by hybrid and fully online classes, plans for ongoing professional development, and how institutions are preparing for virtual learning for their students. A big question being asked is "how can I help students understand they are in control of what they're learning?" The problems seen have been students are having difficulties moving online with lack of resources, not being tech savvy and a difficulty with guiding students online. A probable solution would be making guidelines outlining differences in online, remote, and hybrid teaching for faculty and students. Finally, they discussed how faculty can

make short clips talking about their before and after training thoughts and addressing that laptops as a resource have been ordered, but due to social distancing, programming is taking longer than planned.
